'NO FISHING SIGNS' POSTED ON BRIDGES

RVCA SURVEY - COMMENTS REQUESTED

RVCA and the RVCA Security Committee have recently received a number of similar emails over the past few months expressing concern about fishing on the bridges. Based upon review of the calls to the patrol cell phone, it appears to be the number one complaint at this time.

Many of you have expressed concerns about fishing along the bridges leading to the Isles of Rio Vista. The concerns expressed have ranged from parking and traffic issues to littering and noise complaints, as well as reports of actual crime.

Due to safety concerns, the City Attorney has approved 'NO FISHING' signs for each of the Isle bridges.

Before proceeding, we want to ensure that there is a consensus in the neighborhood to make each of these bridges 'NO FISHING' bridges.

If they are so designated, these 'NO FISHING' signs will apply to everyone, including Rio Vista residents and guests, but they will apply **ONLY** to fishing from these neighborhood bridges.
